The characteristics of the Islamic worldview according to Syyaid Qutb and Syed Muhammad Naquib Al-Attas[8]is as follows:

- The view that is Rabbani is sourced from God in the form of revelations contained in the holy book of Al-Qur'an which is still awake to this day. The difference from other worldviews is that they originate from the human mind.
- b Tsabat is constant, which means there is no change in the adjustment of life and thought like human nature which is basically designed the same, there has been no change until now.
- c Comprehensive, namely behavior and thoughts that believe in the One God as the first source of knowledge.
- d Balanced, which means a balanced Islamic view of life between the revelations received by humans with full faith and belief because they believe that human reason is limited.
- e Positive, which means that all human obedience to Allah SWT creates a positive attitude in his life.
- f Pragmatism, namely the role of humans in the reality of life is only given to the extent of the capabilities and needs of humans themselves and is not forced to play a role at the divine level.
- g Tawhid which means God is One and nothing created can equal it.

Education Concept
